

The Greater Louisville region is comprised of 15 counties across Kentucky and Southern Indiana. It is home to more than 1.5 million people and over 83,000 businesses. The region's central location affords it the logistical advantage of being within a day's drive of two-thirds of the U.S. population.

Additionally, the Greater Louisville region is a relatively inexpensive place to live with a ranking of 96.8 on the cost

of living index scale. Kentucky and Indiana rank 92.4 and 95.5 respectively on the scale.

The business services and technology industry represent 2.8% of total employment in the Kentucky-Indiana bi-state area. The Greater Louisville Region is comprised of 4,449 business services and technology businesses that employ over 23,000 people. From 2018-2024, the business services and technology industry in Greater Louisville grew by 21.1%, at pace with the national average.

Business Services & Technology Ecosystem

Furtherance of a regional technology sector that focuses on existing cluster targets of electric vehicle battery production and artificial intelligence will position the region for continued growth.

Greater Louisville offers a broad variety of tech training programs targeted at bringing more diversity to the tech industry by offering free courses to low-income and

marginalized populations. In 2019, a regional initiative called LouTechWorks launched in partnership with Jefferson County Public Schools and regional higher education institutions to expand pathways to learning tech skills through new certifications and degrees, allowing the region to radically scale its talent pipeline.
